SEC. 6-5-1 Town Roads.

(a) **General Authority.**

- (1) The Town Board, by ordinance, shall name all roads within the Town and under the Town's jurisdiction pursuant to Wis. Stats. §§ 60.23(17) and 81.01(11).
- (2) The Town Board, by ordinance, may change the name of a road within the Town and under the Town's jurisdiction pursuant to Wis. Stats. §§ 60.23(17) and 81.01(11).

- (b) **Continuity of Road Names.** The Town shall provide continuity in the naming of roads within the Town whenever possible.

SEC. 6-5-2 Mar-Kay Drive Changed to Johnson Avenue.

The road that is currently named Mar-Kay Drive shall be renamed to Johnson Avenue in the following locations of the Town:

- (a) **Beacon View Terrace.** The recorded plat of Beacon View Terrace, recorded in the office of the Register of Deeds for Racine County on March 18, 1958 in Volume X of Plats, at page 8, as Document No. 672710, shall be corrected to change the name of the road Mar-Kay Drive to Johnson Avenue.
- (b) **Beacon View Terrace No. 2.** The recorded plat of Beacon View Terrace No. 2, recorded in the office of the Register of Deeds for Racine County on December 30, 1964 in Volume 27 of Plats, at page 64, as Document No. 781315, shall be corrected to change the name of the road Mar-Kay Drive to Johnson Avenue.
- (c) **Storm Sewer Drainage Easement area in the Award of Damages.** The recorded document entitled Award of Damages recorded in the office of the Register of Deeds for Racine County on July 24, 1986 in Volume 1811 of Records, at page 283-284, as Document No. 1200707 shall be corrected to reflect that the name of the road in the easement area shall be Johnson Avenue and is legally described as:
That part of the Southwest ¼ of the Northwest ¼ of Section 28, Township 4 North, Range 23 East, in the Town of Caledonia, Racine County, Wisconsin, bounded as follows: Commence at a standard Racine County monument with a brass cap marking the Northwest corner of said Northwest ¼; run thence S00° 27' 48" E 1320.63 feet on the West line of said Section to the North Line of Wedgwood Park, a recorded plat; thence N88° 32' 45" E 500.57 feet on said North line to the East

line of Wedgewood Park; thence S00° 27' 48" E 264.57 feet on said East line to the North line of Johnson Avenue and the point of beginning of this description; run thence S75° 27' 48" E 498.47 feet; thence N88° 32' 09" E 309.00 feet; thence N43° 32' 09" E 46.38 feet to the East line of the Southwest ¼ of said Northwest ¼; thence S00° 26' 43" E 77.80 feet on said East line; thence N89° 41' 46" W 346.75 feet; thence N75° 27' 48" W 492.72 feet to the East line of Wedgewood Park, a recorded plat; thence N00° 27' 48" W 46.59 feet to the point of beginning. Containing 0.879 acre. Tax No. 04-23-28-046-000 (re-numbered 04-23-28-046-010).
